### January

18 Estimated Tax Payment for 4th Quarter of 2021 (Form 1040-ES)

#### April

- 1 First Required Minimum Distribution (RMD) by Individuals Who Turned 72 in 2021
- 18 File 2021 Tax Return (Form 1040) and Pay Tax Due
- 18 File Form 4868 to Request 6-Month Income Tax Return Filing Extension
- File Schedule H (1040) and Pay Employment Taxes for Household Employees (file separately if Form 1040 is not filed)
- 18 Estimated Tax Payment for 1st Quarter of 2022 (Form 1040-ES)
- 18 Contribute to Individual Retirement Account (IRA) for 2021
- 18 Withdraw Excess IRA Contributions in 2021 if Filing of Form 1040 Was Not Extended
- 18 Contribute to Health Savings Account (HSA) for 2021
- 18 Contribute to Solo 401(k) Plan or Simplified Employee Pension (SEP) Plan for 2021
- 18 File 2018 Tax Return (Form 1040) to Request Unclaimed Tax Refund for the 2018 Tax Year

- 15 Return Filing Extension (payment of tax not extended)

# September

15 Estimated Tax Payment for 3rd Quarter of 2022 (Form 1040-ES)

#### October

- File Extended 2021 Tax Return (Form 1040) and Pay Tax Due
  Withdraw Excess IRA Contributions in 2021 to Avoid Penalty if Filing of Form 1040 Was
- 17 Extended Contribute to Solo 401(k) Plan or Simplified Employee Pension (SEP) Plan for 2021 by Self-
- 17 Employed if Filing of Form 1040 Was Extended

#### December

- Contribution to Employer-Sponsored Retirement Plan for 2022 (401(k), 403(b), 457 or federal thrift savings plans)
- Required Minimum Distribution (RMD) by Individuals Who are 73 or Older at the End of 2022
